Pursuant to Ordinance 2014-01, there shall be a Five Dollars (\$5.00) annual registration fee assessed for each Rental Unit located within the Town of New Chicago.

1. Rental registration fee of \$5.00 per each rental unit, whether vacant or occupied (only cash, check or money order accepted)
2. Proof of ownership (mortgage, deed, property tax statement, etc.)

4. Copy of valid driver's license or State issued identification
5. Occupant information
6. Owner and contact information for the Owner
7. Address of Rental Property
8. A local contact person with contact information in the case of an absentee owner.

A late fee shall be assessed in the amount of \$100.00, in addition to the registration fee, for each dwelling or rental unit not registered. The late fee will not begin being assessed until April 15, 2018. Failure to register any and all real property utilized as rental housing shall constitute a violation of this Ordinance and the owner shall be subject to a fine not to exceed \$2,500.00 per unit. 2018 Registrations will be received Monday through Friday between the hours of 9:00 a.m. and 3:00 p.m.
