- -Whereas, the Town of New Chicago desires to ensure the professionalism of its employees for the best interests of the citizens of New Chicago.

The following sections of Chapter Four of the New Chicago Town Code shall be amended as follows: Section 4-42 (d) shall be replaced and amended to read as follows:

"Any employee who is absent from work for three (3) days or more consecutive work days shall be required to provide his/her immediate supervisor with a physician's statement setting forth the medical reason for absence and furthermore releasing the employee to return to work."

Section 4-43 (a) shall be replaced and amended to read as follows:

Military Leave. An employee who is a member of the Reserve Armed Forces of the State of Indiana or the United States shall be entitled to an unpaid leave of absence for not more than fifteen (15) calendar days annually. To receive such leave, the employee must bring notification of service papers upon receipt to the office of the Clerk-Treasurer.

Section 4.75 (a) shall be replaced and amended to read as follows:

- (a) No item shall be sold or offered for sale within the Town of New Chicago which is infected by mold, lice, bedbugs, lead pain or infectious disease pathogens.
- (b) Any used clothing, bedding, blankets, curtains, towels, or stuffed animals, shall be laundered prior to sale of an offer to sell.
- (c) No secondhand electric or electronic item shall be sold or offered for sale which has not been tested to ensure that it is in working order.
- (d) No furniture or tools shall be sold or offered for sale which appears to be structurally unsound, unduly dangerous, or painted with lead paint.
- (e) No secondhand toys shall be sold or offered for sale in New Chicago which are painted with lead paint.
- (f) Sellers of secondhand goods take reasonable efforts to ensure that all merchandise sold is safe and is in accordance with this article. The failure to have proper precautions in place, including but not limited to the inspection of merchandise prior to sale, may be deemed as violation of this article.

### **Ordinance 2018-02**

Whereas, the Town of New Chicago seeks to ensure the safety of all citizens on the roadways.

Whereas, the Town of New Chicago seeks to ensure adequate parking is available for all citizens.

Whereas, the Town of New Chicago believes that parking of an unlimited number of cars on the public right of way restricts parking options, is potentially hazardous, and may reduce property values for surrounding property owners or businesses.

Therefore, it is hereby ordained by the Town of New Chicago, that a new section of the Town Code, to be designated section 23-73 shall be added to the Town Code as follows:

- (a) No property owner or tenant shall have more than five (5) vehicles parked on the public right of way.
- (b) This ordinance shall apply to any vehicles parked for at least three (3) hours.
- (c) In the event that any person has a short-term need for additional parking, said individual may apply for a short-term parking permit at the office of the New Chicago Police Department at least ten days before requiring such parking. Said request shall list the purpose for the additional parking requirements.
- (d) The Police Department may issue a short-term parking permit
- (e) No permit shall be granted for more than seven days.
- (f) Each car in excess of five (5) shall constitute a separate violation.
- (g) A violation of this ordinance shall be considered a nuisance and may result in an ordinance violation being assessed against the property owner or tenant.

- Whereas, the Town of New Chicago believes it is in the best interests of the citizens, property values, and other businesses currently located within the Town of New Chicago that there would be a system in place to research the businesses seeking to operate within the Town of New Chicago.

NOW THEREFORE, it is hereby ordained by the Town Council of the Town of New Chicago that Ordinance 17-71 of the Town Code shall be hereby amended to read as follows:

- (a) Any person, by himself or through an agent, employee or partner, who holds himself further as being engaged in a business or occupation; or solicits patronage therefore, actively or passively; or performs or attempts to perform any part of such business or occupation in the Town shall be subject to the licensing requirements herein.
- (b) This article shall not apply to a home occupation business.
- (c) Person includes any type of legal entity.
- (d) Failure to register a business under this article is a Town ordinance violation.
- (e) Any business violating any provision of this article shall be fined not less than one hundred dollars (\$100.00). A separate offense shall be deemed committed on each day in which a violation occurs or continues.
- (f) Each and every store or location operated shall constitute a separate business and shall require a separate license and fee.

### Ordinance No. 2018-05

An ordinance Amending Article 17 of the Town Code

- Whereas, the Town of New Chicago presently has ordinances in effect regarding the licensure of businesses.
- Whereas, the Town of New Chicago deems it desirable to clarify the parameters of said regulations.
- Whereas, the Town of New Chicago believes it is in the best interests of the citizens, property
  values, and other businesses currently located within the Town of New Chicago that there would
  be a system in place to research the businesses seeking to operate within the Town of New
  Chicago.

NOW THEREFORE, it is hereby ordained by the Town Council of the Town of New Chicago that Ordinance 17-75 of the Town Code shall be hereby amended to read as follows:

- (a) Upon the receipt of an application for a license where an ordinance of the Town necessitates an inspection or investigation before the issuance of such license, the Town Clerk-Treasurer shall refer such application to the proper office(s) for making any necessary inspections within seventy-two (72) hours of the time of such receipt. The deadline may be extended if the deadline falls upon a weekend or legal holiday.
- (b) All new businesses in the Town of New Chicago or businesses who are seeking to reinstate a suspended or revoked license, as part of the business license application, are required to submit to a general business inspection for the purposes of ensuring that all Town of New Chicago Codes and regulations are being followed.
- (c) A background check must be satisfactorily completed in accordance with section 17-76.
- (d) This business licensing ordinance is intended to supplement the Town's hazardous materials ordinance.
- (e) The proposed license shall not be referred to the Planning Commission until all necessary inspections of the proposed site of the property have occurred. This includes, but may not be limited to, building codes, hazardous materials, or any other ordinances of the laws of the Town of New Chicago or State of Indiana.
- (f) The officer charged with the duty of making any necessary inspection or investigation shall make a report thereon, favorable or otherwise, within ten (10) working days after receiving the application or a copy thereof.
- (g) Procedures for obtaining a license
  - (1) Once all necessary steps in subsections (a) through (f) of this section have been completed, the Clerk-Treasurer shall forward the proposed business license to the Planning Commission to be placed on the agenda.

- (2) The proposed business owner, or an authorized representative who has been designated in writing, shall appear before the Planning Commission.
- (3) The Planning Commission shall conduct a hearing to determine if the business is in compliance with law. The counsel shall make a recommendation to the Town Council to either approve or deny the business license.
- (4) Following the recommendation of the Plan Commission, the Town Council shall vote to either approve or deny the license.

An ordinance Amending Chapter 23 of the Town Code

- Whereas, the Town of New Chicago wishes to ensure the traffic safety of the citizens of New Chicago.
- Whereas, the Town of New Chicago is presently experiencing deteriorating roadways.
- Whereas, this deterioration is exacerbated by the passage and parking of large and overweight vehicles on public roadways.

NOW THEREFORE, it is hereby ordained by the Town Council of the Town of New Chicago that Ordinance 23-97 of the Town Code shall be hereby amended to read as follows:

- (a) Vehicles exceeding five thousand (5,000) pounds shall not be parked within any residential zone of the Town of New Chicago except for loading and unloading of vehicles in compliance with section 23-2 of this code.
- (b) The violation of this Ordinance will be punishable as follows with each day counted as an additional offense:
  - (1) First offense One hundred dollars (\$100.00).
  - (2) Second offense Two hundred fifty dollars (\$250.00).
  - (3) All subsequent offenses Five hundred dollars (\$500.00).

### Ordinance No. 2018-07

An ordinance Amending Article 23 of the Town Code

- Whereas, the Town of New Chicago wishes to ensure the traffic safety of the citizens of New Chicago.
- Whereas, the Town of New Chicago is presently experiencing deteriorating roadways.
- Whereas, this deterioration is exacerbated by the passage of large and overweight vehicles.

NOW THEREFORE, it is hereby ordained by the Town Council of the Town of New Chicago that Ordinance 23-2 of the Town Code shall be hereby amended to read as follows:

### (a) Purpose

- (1) Whereas, the Town of New Chicago has numerous roads in the community which are constructed in such a fashion that they can be easily damaged by heavy vehicles.
- (2) It would be in the best interests of the safety of the citizens of New Chicago to maintain safe roadways.
- (b) The Town of New Chicago street superintendent or Town Council may restrict the weight on roadways through the town, but no weight limit shall be less than five thousand pounds (5,000) unless section 23-3 applies.
- (c) The Town of New Chicago Street Superintendent or Town Council may post signs restricting the weight of vehicles on any roads within the town of New Chicago.
- (d) This ordinance shall not apply to the following entities and uses:
  - (1) Local deliveries.
  - (2) Construction equipment intended for use within the Town of New Chicago.
  - (3) Garbage trucks operated by the town's contracted garbage vendor.
  - (4) Any highway in the state highway stem or route maintained by the State of Indiana.
- (e) Nothing in this section shall be construed to restrict or otherwise limits the Town's powers stated in section 23-3 of this Code.
