# **Town Council Meeting**

## 6:00 pm

## Call to Order:

The meeting was called to Order by the Clerk Treasurer with the Pledge of Allegiance.

## Payment of Bills:

Member Anderson made motion to approve the bills, seconded by Member Swallow; motion carried unanimously.

# Fund & Appropriation Reports:

Member Anderson made motion to accept the Fund & Appropriation reports for January, seconded by Vice-President Gibson; motion carried unanimously.

### Minutes:

Member Swallow made motion to approve the minutes from the January 9, 2022 meeting, seconded by Member Grecco; motion carried unanimously.

## Correspondence:

- A. DWSRF Request for Payment #6 to Abonmarche for \$2,400: Member Swallow made motion to approve, seconded by Member Grecco; motion carried unanimously.
- B. Advanced Sewer Services, Inc.: Vice President Gibson made motion to extend their contract for two (2) more years until 12/31/2023, seconded by Member Grecco; motion carried unanimously.
- C. Cumulative Capital Development: Discussion took place regarding increasing the current rate to the maximum of five cents. Vice-President Gibson made motion to re-establish CCD at the five cents rate, with no one willing to second, President Szwedo put down the gavel and seconded the motion; motion passed with Member Swallow opposing.

- D. Sanitation: Discussion took place regarding the current sanitation rates charged to residents vs. the current sanitation rates charged to the town. This is the last year of the contract with Total Disposal. Decision was made for Council to think this over and then discuss next month at the Council meeting.
- E. ILMCT Conference: Clerk Treasurer requested Council approved to attend the annual conference in Muncie, IN in March. Vice-President Gibson made motion to approve the Clerk Treasurer attending, seconded by Member Swallow; motion passed unanimously.

# Departments:

#### Police

- Chief Senzina stated that the police department has 6 officers, including the Chief.
- Chief Senzina stated the police had 80 citations, of which 73 were local ordinances and 7 were warning tickets.
- Since the department currently has no officer qualified to do FTO training, Sgt.
   Mayo volunteered to attend the State Certified FTO Training 2/28/2022 3/2/2022 and the Chief is seeking Council approval. Vice-President Gibson made
   motion to approve the training, seconded by Member Grecco; motion carried
   unanimously.

### Fire:

- Chief Eakins stated the Fire Department has had 47 calls for service.
- Chief Eakins stated that they have 14 firefighters, with a new applicant expected this coming Sunday, February 13, and a possibly one more applicant soon.

# **Town Manager**

- Looking for donation of \$10,000 to help pay for replacing the stolen chipper.
- Town Manager attended the Forum at the Glen last Saturday, February 5, 2022.
   Michael Griffin is our new State Senator. Charlie Brown is our new State
   Representative.

### Parks Board:

- Needs new trash cans for the park. They found garbage cans that can be secured
  and yet easy to handle by Park Board members. They would like to purchase 8 of
  them at \$79.00 each and looking for Council approval. Member Anderson made
  motion to approve the purchase, seconded by Member Swallow; motion passed
  unanimously.
- Park Board would like to amend the 2008-07 Ordinance which would make all Deposits \$100 across the board, and lowering funding for fundraising groups and free for non-profit groups. Council agreed and Park Board was told to proceed.
   New amended Ordinance should be prepared to next month's meeting.

• Easter Egg Hunt is scheduled for the Saturday before Easter, April 16, 2022. Park clean-up is scheduled to occur the weekend prior.
